END USER LICENSE AGREEMENT
(Effective: [DATE])**

YOU SHOULD CAREFULLY READ THE FOLLOWING TERMS AND CONDITIONS BEFORE USING THIS PRODUCT. BY CLICKING THE ACCEPTANCE BUTTON, ACCESSING THE SERVICES, OR USING THE SERVICES, YOU ARE CONSENTING TO BE BOUND AND ARE BECOMING A PARTY TO THIS END USER LICENSE AGREEMENT.

This End User License Agreement (this “EULA”) sets forth the terms and conditions of your use of the software (the “SaaS Product”) offered by Bluspark Global, LLC and its Affiliates (“Bluspark”). For the purposes of this EULA, “you” means you, the end user. You represent and warrant that you are a “Authorized User” of a Bluspark customer.

1. License Grant. Bluspark hereby grants to you a non-exclusive and non-transferable worldwide license to use the SaaS Product and related documentation (the “Documentation”) solely for the intended purposes of the SaaS Product as set forth in the Documentation or as communicated by Bluspark, as applicable, according to the provisions contained herein and subject to payment of applicable license fees. You are not permitted to lease, rent, distribute or sublicense the SaaS Product or any rights therein. Further, no license is granted to you in the human readable code of the SaaS Product (source code). Except as provided below, this EULA does not grant you any rights to patents, copyrights, trade secrets, trademarks, or any other rights in the SaaS Product or Documentation.

You agree that you have no license, right, power or authority to make any modifications to or unauthorized copies of the SaaS Product. You may not remove or alter any trademark, logo, copyright or other proprietary notices, legends, symbols or labels in the SaaS Product. You may not release the results of any performance or functional evaluation of the SaaS Product without Bluspark’s written consent. You represent and warrant that you are at least eighteen (18) years of age.

You hereby grant to Bluspark a non-exclusive, worldwide right to use any content, data, materials, and information that you input or cause to be input (“Customer Materials”) into the SaaS Product as necessary to provide the SaaS Product to you. Additionally, you hereby grant to Bluspark a non-exclusive, perpetual, irrevocable, worldwide right to de-identify and aggregate non-personal data for Bluspark’s business purposes, and to make available to others. You represent and warrant that you have the authority to enter into this EULA and the right to disclose all data required for Bluspark to provide the SaaS Product to you.

2. No Assignment; No Transfer. You agree not to transfer or assign the SaaS Product to another party without the prior written consent of Bluspark.

3. No Modification; No Reverse Engineering. You agree not to modify, translate, reverse engineer, decompile, disassemble, or create derivative works of the SaaS Product or assist a third-party in performing such prohibited acts. Additionally, you agree not to remove or alter any notices of intellectual property right or confidentiality or similar legends appearing in or any aspect of any SaaS Product. You may not use or access the SaaS Product to create or assist a third-party in creating a competing product to the SaaS Product.

4. Import/Export Restrictions. You agree not to import or export the SaaS Product and any Documentation (or any copies thereof) or any product utilizing the SaaS Product or any Documentation in violation of any applicable laws of the United States or the country to which you have imported or exported. You agree to indemnify Bluspark from any liability resulting from your violation of such laws or regulations.

5. Title. You agree that Bluspark and its licensors own all rights and title to the SaaS Product and any Documentation and all subsequent copies thereof regardless of the form or media. You shall not claim any right, title, or license to the SaaS Product or any Documentation other than those specifically granted to you by Bluspark.

6. Accounts and Passwords. You will choose user logins and passwords to use the SaaS Product. You will be responsible for maintaining the confidentiality of all user logins and passwords and for ensuring that each user login and password is used only by the user to which it was issued. You agree to immediately notify Bluspark of any unauthorized use of any account or login and password issued to you or any other breach of security known to you. Bluspark shall have no liability for any loss or damage arising from your failure to comply with the terms set forth in this Section.

7. Term and Termination. This EULA is effective on the first date that you use or access the SaaS Product and will continue for as long as you use or access the SaaS Product. Your license for the SaaS Product may be terminated immediately if you fail to comply with any term or condition of this EULA. Upon such termination, you agree to cease use of the SaaS Product and Documentation immediately. You agree that you will not be entitled to a refund of any applicable license fee upon early termination of this EULA for your breach.

8. Governing Law. The laws of the state of New York shall govern the construction of this EULA, without regard to any conflict or choice of law principles, and you agree to be subject to personal jurisdiction in the state of New York for the purposes of enforcing the provisions of this EULA.

9. Confidential Information. “Confidential Information” means the SaaS Product, source code, object code, trade secrets, know-how and any proprietary tools, knowledge, information or methodologies of Bluspark not generally available to the public, to which you may gain access or knowledge as a result of this EULA. You will keep such Confidential Information in confidence and shall use reasonable efforts and take all reasonable steps to protect such Confidential Information from any use, reproduction, publication, disclosure, or distribution except as specifically authorized in this EULA. You will notify Bluspark of any known unauthorized use or disclosure of Confidential Information and will cooperate with Bluspark in its actions to protect its proprietary rights.

10. Limited Warranty. BLUSPARK WARRANTS THAT THE SAAS PRODUCT, IN UNMODIFIED FORM AND WHEN USED AS AUTHORIZED BY BLUSPARK, THIS EULA, AND THE DOCUMENTATION, WILL SUBSTANTIALLY CONFORM TO THE PRODUCT SPECIFICATIONS PROVIDED BY BLUSPARK DURING THE TERM. BLUSPARK MAKES NO OTHER WARRANTIES OR REPRESENTATIONS RELATING TO THE SAAS PRODUCT OR ITS PERFORMANCE OR WITH RESPECT TO THE DOCUMENTATION. ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING THOSE OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT, ARE EXPRESSLY DISCLAIMED AND EXCLUDED.

11. Limitation of Liability. UNDER NO CIRCUMSTANCES AND UNDER NO LEGAL THEORY SHALL BLUSPARK AND ITS AFFILIATES, OFFICERS, EMPLOYEES, CONTRACTORS, SHAREHOLDERS, OR SUPPLIERS, BE LIABLE TO YOU OR ANY OTHER PERSON FOR ANY INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY KIND INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF GOODWILL, LOST PROFITS, BUSINESS INTERRUPTIONS, WORK STOPPAGE, COMPUTER FAILURE OR MALFUNCTION, OR ANY AND ALL OTHER PERSONAL OR COMMERCIAL DAMAGES OR LOSSES ARISING FROM THE USE OR INABILITY TO USE THE SAAS PRODUCTS (WHETHER OR NOT DUE TO ANY DEFECTS THEREIN). IN NO EVENT WILL BLUSPARK BE LIABLE FOR ANY DAMAGES EVEN IF BLUSPARK SHALL HAVE BEEN INFORMED OF THE POSSIBILITY OF SUCH DAMAGES OR

SUCH DAMAGES WERE REASONABLY FORSEEABLE, OR FOR ANY CLAIM BY ANY OTHER PARTY. THIS LIMITATION OF LIABILITY SHALL NOT APPLY TO LIABILITY TO THE EXTENT APPLICABLE LAW PROHIBITS SUCH LIMITATION. IN NO EVENT SHALL BLUSPARK'S LIABILITY EXCEED THE MONTHLY SUBSCRIPTION FEE PAID FOR THE SAAS PRODUCT.

12. Indemnification. You agree to defend, indemnify, and hold harmless Bluspark and its affiliates, officers, employees, contractors, members, shareholders, or suppliers from and against liabilities, costs, damages and expenses (including settlement costs and reasonable attorneys' fees) arising from any third-party claims that relate or result from your use, reproduction or distribution of the SaaS Product, or your breach of any representation, warranty or obligation under this EULA.

13. Severability. IN the event any provision of this EULA is found to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of any of the remaining provisions shall not in any way be affected or impaired.

14. Entire Agreement. You further agree that this EULA is the complete and exclusive statement of the agreement between you and Bluspark, which supersedes all proposals or prior agreements, oral or written and all other communications between you and Bluspark relating to the subject matter of this EULA. This EULA may be modified by Bluspark from time to time, at its discretion. Such modifications shall be effective as of the date provided in such modification.

15. Acknowledgement. By accessing or using any part of the SaaS Product, you indicate that you have read this EULA, understand it, and agree to be bound by its terms and conditions.

16. Customer Materials Waiver. You acknowledge that use of the SaaS Product, like with any cloud-based software, necessarily involves the transmission of Customer Materials over networks that Bluspark does not own, operate or control. You agree that Bluspark shall not be held responsible for any Customer Materials that is lost, altered, intercepted, or stored across such networks. Bluspark cannot guarantee that security procedures will be error-free, that transmissions of Customer Materials will always be secure, or that unauthorized third-parties will never be able to defeat security measures implemented by Bluspark or by third-party service providers. You acknowledge and agree that Bluspark shall not be liable for delays, interruptions, service failures or other problems inherent in the use of cloud-based software, internet and electronic communications, or other systems outside of Bluspark's reasonable control. Any statutory warranties or rights granted to you shall be limited to the shortest time period permitted by law, and as narrowly as permissible.

17. Force Majeure. Bluspark shall not be liable hereunder for any failure or delay in the performance of its obligations under this EULA if such failure or delay is on account of causes beyond its control, including labor disputes, epidemics and pandemics, civil commotion, war, fires, floods, inclement weather, governmental regulations or controls, casualty, government authority, strikes, or acts of God, in which event Bluspark shall be excused from its obligations for the period of the delay and for a reasonable time thereafter.
